There have been increased discussion around homelessness measures in the City of San Rafael. PGHOA board officers have been in regular contact with elected officials and city hall staff on this matter. This is the response from the city:

There are no encampments sited on any other <u>City Parks at this time</u>. The City continues to evaluate Ordinance 2040, which regulates camping on city-owned, public property. Staff are planning to present an update to the City Council regarding this Ordinance at a public City Council meeting later this Spring.
